Prospective Member Information

1. Complete member proposal form provided by Rotary sponsor
2. Return completed member proposal form to Rotary sponsor
3. Proposal is given to club secretary
4. Proposal presented to board for review and action
5. Proposal read to club
6. After seven (7) days, if no objection, proposed member inducted into club at next convenient club meeting
8. Club dues are \$40 per quarter billed in arrears (due within 30 days)
9. Corporate membership dues are \$50 per quarter (due within 30 days)
 - a. Corporate member may have one senior designee and up to three (3) additional designees
 - b. Attendance/meal credit given for any designee that attends a meeting
 - c. Additional meal charge for each additional designee attending
10. Meals are \$8 per week billed in arrears quarterly (due within 30 days)
A request can be made in advance to opt out of meals on a quarterly basis.
11. Recommend \$25 per quarter contribution to The Rotary Foundation - payable with quarterly dues and meals (member determination)
12. Recommended, but not required, to attend 60% of club meetings (participation in club project earns one (1) meal credit)
13. Attendance at another Rotary Club meeting earns one (1) meal and one (1) attendance credit
